Participant agrees to waive and relinquish all claims Participant may have as a result of the Event against Dan Rothert Student Athlete Advising LLC and its employees and agents and does hereby fully release and discharge Dan Rothert Student Athlete Advising LLC and its employees and agents from any and all claims for injuries, including death, damage or loss which Participant may have or which may accrue to Participant as a result of, or arising out of, connected with, or in any way associated with the Event, even if caused by the negligence of Dan Rothert Student Athlete Advising LLC, its employees or agents.

Participant further agrees to INDEMNIFY AND HOLD HARMLESS AND DEFEND Dan Rothert Student Athlete Advising LLC and its employees and agents from any and all claims for injuries, including death, damages and losses sustained by Participant as a result of, arising out of, connected with, or in any way associated with the Event, even if caused by the negligence of Dan Rothert Student Athlete Advising LLC, its employees or agents.

Therefore, Participant must look to their own health insurance policy for any injuries sustained in connection with or arising out of this Event.
