Please read this form carefully and be aware that by participating in the TSA Recruiting IHSSCA Senior All-Star Classic on November 19, 2024 (hereinafter “Event”) you will be waiving and releasing all claims for injuries, agreeing to indemnify, hold harmless, and defend Dan Rothert Student Athlete Advising LLC (hereinafter “Host”) from all claims arising out of such injuries or illnesses, even if caused by the “Host”, and authorizing the “Host” to obtain emergency healthcare at your expense.

Participant agrees to waive and relinquish all claims Participant may have as a result of the Event against the “Host” and its employees and agents and does hereby fully release and discharge the “Host” and its employees and agents from any and all claims for injuries, including death, damage, or loss, which Participant may have or which may accrue to Participant as a result of, or arising out of, connected with, or in any way associated with the Event, even if caused by the negligence of the “Host”, its employees, or agents.

Participant further agrees to indemnify, hold harmless, and defend the “Host” and its employees and agents from any and all claims for injuries, including death, damages, and losses sustained by Participant as a result of, arising out of, connected with, or in any way associated with the Event, even if caused by the negligence of the “Host”, its employees, or agents.

Participant further understands that the “Host” does not carry insurance for injuries or illnesses sustained by Participant. Therefore, Participant must look to their own health insurance policy for any injuries sustained in connection with or arising out of this Event. Participant’s failure to purchase health insurance coverage does not make the “Host” responsible for the payment of medical or other expenses.

In the event of an emergency, Participant authorizes the “Host” to secure any treatment deemed necessary from any licensed hospital, physician, and/or medical personnel and agrees to be responsible for payment of any and all services rendered.

Participant grants permission to the “Host” to use my image (photographs and/or video) for use in media publications, including videos, email marketing, recruiting brochures, website, and/or social media.
